**Notification, Submission, Public Inspection of and Explanation Sessions for Preliminary Environmental Assessment Method Statement for the Tentatively Named Shimizu Natural Gas Power Plant Construction Project**

TonenGeneral Sekiyu K.K. (head office: Minato-ku, Tokyo; president: Jun Mutoh; "TonenGeneral" herein), in accordance with the Environmental Impact Assessment Law, has submitted notification of a document entitled Environmental Impact Assessment Method Statement for the Tentatively Named Shimizu Natural Gas Power Plant Construction Project ("the statement" herein) to the Minister of Economy, Trade and Industry, and has submitted the statement to the governor of Shizuoka prefecture and the mayor of Shizuoka City.
